## Saturday, October 19, 2019 Under the HWY 90 Bridge in Downtown Morgan City

**2:00 – 3:45 STRICTLY** vehicles that are participating in handing out candy will be allowed to park under the bridge at their assigned location. Each participant will be given a number to find where to park. All vehicles **MUST** be ready for trick or treaters by 4:00 PM when we will countdown to Trunk or Treat. All vehicles that are **NOT** participating in handing out candy please park elsewhere downtown and walk to the location. Vehicles parked in the area for those handing out candy that are **NOT** handing out candy will be asked to move. Officers will be on site.

**4:00 – 6:00** Trunk or Treat begins & judges will be walking around to pick the winners for the best decorated vehicle.

**6:00– 6:30** We will announce the winners of the vehicle competition and judge for the costume contest. *(Children only for the costume contest)*

\*\*\*There is the possibility of Main Street hosting a Haunted House AFTER Trunk or Treat is finished in order to raise funds for the Block 27: Lawrence Park Improvement Project. We will follow up with more information if this comes to fruition. \*\*\*

**RULES:**

- We will take participation forms until all spaces are filled. Spaces are filled on a first come, first serve basis. If anyone who claims a space cannot attend for some reason, please let Beth know as soon as possible.
- No open flames, fireworks or flammable materials
- Cars must be turned off for the duration of the event
- No electricity will be available
- Must plan on having enough candy for at least 1,200 children
- PARENTS/GUARDIANS MUST WATCH CHILDREN
- This is an ALCOHOL FREE event. Anyone caught with alcohol will be asked to leave the premises.
- Vehicles CANNOT leave during the event as it would be extremely dangerous. In the event of an Emergency, please notify Beth, the MCFD or MCPD and we will help you vacate the premises safely.
